The Allegheny Intermediate Unit (AIU) has engaged a variety of internal and external stakeholders in several ways regarding the use of ARP ESSER funds. External Stakeholders: The AIU's 13-member board of directors is comprised of school board directors from Allegheny County's 42 suburban public-school districts. These leaders are elected every year by the 378 board members in suburban Allegheny County. Through this governing structure, the AIU maintains a collaborative partnership with its member school districts. Discussion of the ARP ESSER fund usage, as well as the project that was ultimately funded, was featured prominently at multiple public meetings that were hosted both in-person and online. Internal Stakeholders: Internal stakeholders consisted of AIU employees, nearly 300 of whom are assigned to the AIU's Central Office. A subset of this group consisted of members of the AIU's Executive Leadership Team, which includes leaders of the AIU's three programming divisions as well as internal services and systems. This team discussed the use of ARP ESSER funds from both a program perspective and its impact on the larger agency as a whole.

Both external and internal stakeholder groups engaged in robust and thoughtful discussion regarding the intended usage of ARP ESSER funds. A wide variety of execution and implementation strategies were considered. Stakeholder groups repeatedly cited concerns regarding COVID-19 and the Central Office's aging physical environment and life support systems. Specifically, stakeholders voiced concerns about the lack of proper ventilation, air movement, COVID-19 and other air-borne pollutants, back drafting, unstable heating, and cooling patterns as well as increased maintenance costs, equipment malfunctions, breakdowns as well as a general lack of clean air and stable temperatures. The Central Office conference spaces and training rooms are used extensively to support school entities and the

community organizations and programs that the AIU serves. As a direct result of this feedback, replacement of the building's aging HVAC system was expedited and prioritized in a general construction project that was already underway. While the problematic HVAC system had already been flagged as an area of concern by the agency's architectural and engineering firm, the engagement process contributed to an increased understanding of the broadly held concerns related to COVID-19 exposure in the workplace.

Once planning was finalized, plans will once again be shared with the AIU's board of directors for final approval. To promote transparency, the plan will be created in a language that is understood by stakeholders and made available in alternate formats when needed by those with disabilities. Public notice will be given, and the plan will then be posted on our website and be made available in hard copy. It will be submitted to PDE within 90 days of LEA receipt of ARP ESSER funding.
